The attending physician shall document the order for the consultant and indication of the reason for the consultation on the Physician Orders section in the patient's medical record. A consultation will not be considered fully requested or authorized unless the attending Medical Staff member has personally contacted the consultant or the consultant's office to communicate the request and has written the order and indication for the consultation in the patient's medical record. In an emergency this requirement may be waived. No practitioner is obligated to accept any request for consultation.
- 11. Consent Calendar: These items are expected to be routine and non-controversial. They will be acted upon by the Board at one time without discussion. Any Board Member, staff member or interested party may request an item to be removed from the Consent Calendar for discussion prior to voting on the Consent Calendar.
